

TERMS AND CONDITIONS OF ATTENDANCE AND PARTICIPATION AT POWERFUL PEOPLE CERTIFICATION

These are the terms (the “**Agreement**”) that govern your attendance and participation in the Powerful People Certification (the “**Certification**”).

By registering for the Powerful People Certification you are agreeing to these terms, which form a legal contract between CarlaGradin.com (“**Carla Gradin**”), and the registered attendee (“**Attendee**”).

1. CERTIFICATION PARTICIPATION

1.1. Participation. Your registration entitles you to participate in the Certification. Any and all other costs associated with your attendance (including without limitation any travel and/or accommodation expenses) shall be borne solely by you and Carla Gradin shall have not liability for such costs.

1.2. Termination. You acknowledge that Carla Gradin reserves the right to request your removal from the Certification if Carla Gradin, in its sole discretion, considers your presence and/or behaviour to create a disruption or to hinder the Certification and/or the enjoyment of the Certification by other attendees.

1.3. Media. By attending the Certification you acknowledge and agree to grant Carla Gradin the right at the Certification to record, film, photograph or capture your likeness in any media now available and hereafter developed and to distribute, broadcast, use or otherwise globally to disseminate, in perpetuity, such media without any further approval from you or any payment to you. 1.4. Certification Content. You acknowledge and agree that Carla Gradin, in its sole discretion, reserves the right to change any and all aspects of the Certification, including but not limited to, the Certification name, themes, content, program, location, and time.

2. FEE(S)

2.1. Payment. The payment of the applicable fee(s) for the Certification is due upon registration. **A \$500 non-refundable deposit is due at the time of registration to hold your spot.** The remaining portion plus applicable taxes are due prior to the commencement of the Certification.

3. SUBSTITUTION AND CANCELLATION POLICY

3.1. If you cancel within 48 hours of registering for the Certification course, you will be eligible for a refund for the amount paid less the deposit as long as the date exceeds 10 business days prior to the commencement of the Certification course. Registrations less than 10 business days to commencement of the Certification course will not be eligible for a refund.

3.2. There will be a \$300 substitution fee greater than 10 business days prior to the commencement of the Certification. Less than 10 business days prior to the commencement of the Certification course, and during the Certification process, substitutions are not permitted.

4. INTELLECTUAL PROPERTY

4.1. All intellectual property rights in and to the Certification, the Certification content and all materials distributed at or in connection with the Certification are owned by Carla Gradin. You may not use or reproduce or allow anyone to use or reproduce any trademarks or any materials distributed at or in connection with the Certification for any reason without the prior written permission of Carla Gradin.

5. WARRANTIES AND LIMITATION OF LIABILITY

5.1. Carla Gradin gives no warranties in respect of any aspect of the Certification or any materials related thereto or offered at the Certification and, to the fullest extent possible under the laws governing this Agreement, disclaims all implied warranties, including but not limited to warranties of fitness for a particular purpose, accuracy, timeliness and merchantability. Neither Carla Gradin nor its affiliates can accept any responsibility or liability for reliance by you or any person on any aspect of the Certification and/or any information provided at the Certification.

5.2. Other than to the extent required as a matter of law, Carla Gradin shall not be liable for any direct, indirect, special, incidental, or consequential costs, damages or losses arising directly or indirectly from the Certification or other aspect related thereto or in connection with this Agreement.

6. GOVERNING LAW AND JURISDICTION

6.1. This Agreement shall be governed by the laws of the province of Saskatchewan and the parties shall submit to the exclusive jurisdiction of the Saskatchewan courts.

6.2. All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration in the province of Saskatchewan or another location mutually agreeable to the parties.
